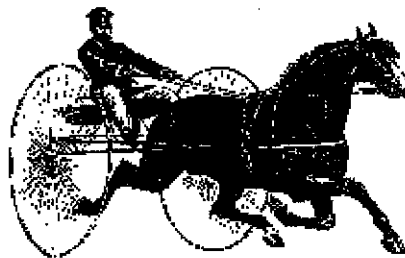

2016-2017 FISCAL YEAR

THIS AGREEMENT made in duplicate this 25<sup>th</sup> day of January 2017, by and between the Board of Education of PORT JERVIS CITY SCHOOL DISTRICT County of ORANGE, NY, party of the first part, and the Board of Education of Goshen Central School District, County of Orange, Goshen, NY, party of the second part.

WITNESSETH, That whereas party of the first part has been duly empowered by the provisions of Section 912 of the Education Law to enter into a contract for the purpose of providing health and welfare services for children residing in said school district and attending non-public schools in Goshen Central School District, County of Orange, Goshen, NY, to begin on September 6, 2016 and to end June 23, 2017.

NOW, THEREFORE, The said party of the first part hereby agrees to pay to the party of the second part the sum of \$6,332.48 for approximately 11 children residing in said PORT JERVIS CITY SCHOOL DISTRICT County of ORANGE, NY and attending non-public schools in said Goshen Central School District, County of Orange, Goshen, NY.

And the party of the second part hereby agrees with the party of the first part as follows:

1. That the health and welfare services provided under Section 912 shall consist of the following:
  - Physician Services
  - Nurse Services
  - School Psychological Services
  - School Speech Correctional Services
  - School Learning Disabilities Services

Such services may include, but are not limited to, all services performed by a physician, annual medical inspections, examination for athletic participation, examinations for employment certificates, nurse, school psychologist, school learning disabilities worker, and school speech correctionist, and may also include vision and hearing tests, the taking of medical histories and the administration of health screening tests, the maintenance of cumulative health records and the administration of emergency care programs for ill or injured pupils.

2. The party of the second part will also furnish the following supplies and equipment to be used in providing such services if requested by the authorities in charge of the non-public school:


