## 2016-2017 CONTRACT FOR HEALTH SERVICES

This agreement made in duplicate this **25th** day of **January 2017**, by and between the **Board of Education of Port Jervis City School District, County of Orange**, State of New York, party of the first part and the Board of Education of the Pine Bush Central School District, County of Orange, State of New York, party of the second part.

WITNESSETH, that whereas the party of the first part being duly empowered under the provisions of Section 912 of New York State Education Law to enter into a contract for the purpose of providing health services for children residing in said school district and attending non-public school in the Pine Bush Central School District, County of Orange, State of New York, for the school year beginning **September 1, 2016 and ending June 30, 2017.** 

NOW, therefore, the said party of the first part agrees to pay to the party of the second part the sum of \$896.04 per student, for health services provided to one (1) child(ren) residing in said Port Jervis City School District of the County of Orange, State of New York and attending non-public school in the Pine Bush Central School District, County of Orange, State of New York.

And the party of the second part hereby agrees with the party of the first part that the service rendered shall consist of the following:

Annual medical inspection
School nursing service
Vision and hearing Tests
Examinations for employment certificates
Examinations for athletic participation
Notification of parents regarding defects and follow up
Instruction for first aid care for school emergencies

And that the party of the second part will also furnish the following equipment to be used in providing such services, if requested, by the authorities in charge of the non-public school:

Scales
Vision testing devices
Hearing testing devices
Health record forms
First aid supplies

It is expressly agreed by and between the parties heretofore mentioned that the services agreed to be supplied under this contract shall not include any teaching services.

It is also mutually agreed that this contract shall not become valid until the same shall be approved by the Superintendent of Schools.
